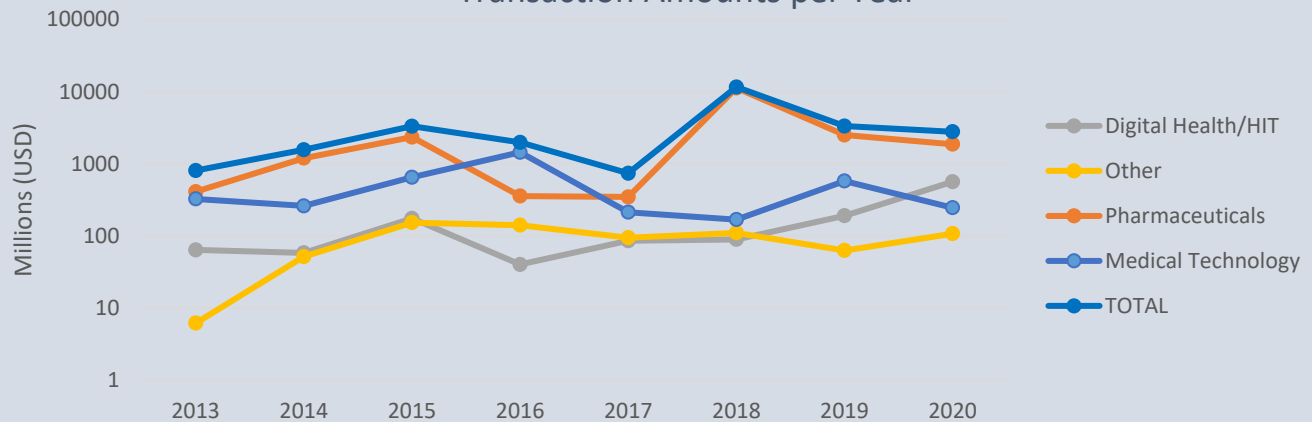

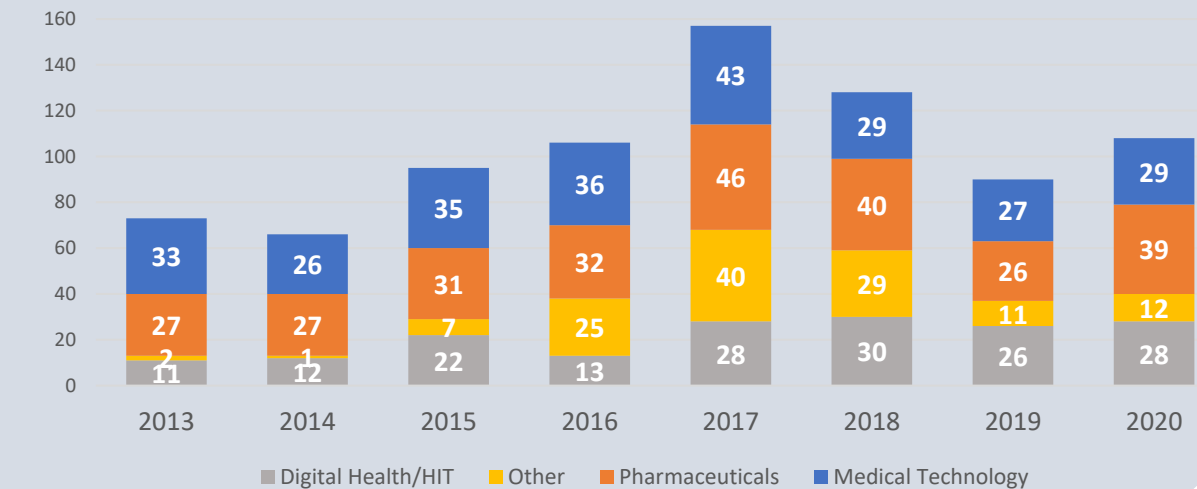
## Washington State Transactions by Sector

## HIGHLIGHTS

- **Silverback Therapeutics** raised \$241M in the second WA-state biotech IPO of 2020 (following Athira Pharma in October 2020). ImmunoTAC, a proprietary software platform, develops therapies that target specific areas of disease without damage to healthy tissue. Silverback’s lead product candidate, SBT6050, uses monoclonal antibodies to target breast, gastric, and lung cancers. ([Geekwire](#); [Silverback Therapeutics](#))
- **Athira Pharma** was awarded \$15M grant from National Institute on Aging (NIA) to support a clinical trial of a treatment that aims to stop deterioration of neurons and restore healthy brain activity in patients with mild to moderate cases of Alzheimer’s disease. - **Freespira** raised \$10M for its product that includes software to coach people using breathing techniques and a CO2 monitor. **Freespira** has FDA approval for treating panic disorder and PTSD. Its headquarters are in Kirkland, WA. ([Geekwire](#); [Freespira](#))
- The FDA issued Emergency Use Authorization for **two COVID-19 vaccines**, the first from Pfizer and the second from Moderna. ([US Food & Drug Administration](#))
- The **Bill & Melinda Gates Foundation** committed an additional \$250M to support research, development, and equitable delivery of lifesaving tools. ([Gates Foundation Press Release](#))
